MINOR/PARTICIPANT RELEASE OF LIABILITY

In consideration of my minor/participant being allowed to participate in any Black Diamond Cheer & Dance (BDCD) and Prima Dance Studio activities and events to include: conditioning, training, practice, games, events, and all other related activities associated with BDCD and the undersigned acknowledges and agrees to the following:

- 1. RELEASE OF LIABILITY:** I for myself and of behalf of my heirs, estate, insurers, successors and assigns, hereby release, indemnify and hold harmless the BDCD organization and their respective officers, directors, agents, representatives, volunteers, successors, assigns, insurers, all activity sponsors and advertisers, and all owners or lessors of premises used in connection with the activities (collectively the "Released Parties") with respect to any and all claims or causes of action the minor/participant may have for damages for personal or bodily injury disability, death loss or damage to person or property relating in any way to the activities, whether arising directly from the negligence of any or all of the Released Parties or otherwise, to the fullest extent permitted by law. BDCD bears no associated risk, assumption of liability for any action or damage to or from Released Parties herein.
- 2. ASSUMPTION OF RISK:** Participation in or attendance at the activities involves inherent risks and dangers of accidents, personal and bodily injury (including death) and property loss or damage. These may result from minor/participant's actions or inactions, as well as the actions or inactions of others (Released Parties), the rules of play and the condition of the facilities and equipment. Further, there may be other risks not known to minor/participant and not reasonably foreseeable at this time. I have considered the nature and extent of the risks involved and voluntarily choose to assume all such risks, both known and unknown, even those risks that result from negligence for the Released Parties (defined above) or others and assume full responsibility for minor/participants involvement in the athletic events. I consent to treatment in the event of an emergency or other incident in which in the reasonable judgment of the on-site personnel, minor/participant requires medical care.
- 3. CERTIFICATION OF GOOD HEALTH:** I certify that my child is in good health and proper physical condition to participate in all BDCD activities and events. I certify that the details stated on the required BDCD medical certification contract are true and correctly stated by a qualified medical physician.
- 4. OUT OF STATE JURISDICTION:** *I authorize BDCD to commute my daughter across state lines on 04-17-15 to Las Vegas Nevada, returning to Corona/Eastvale California) 04-20-15 early am. I certify that I allowed my daughter to participate in the Sharp International National Competition at the Cashman Center on 04-19-15. I am aware that my daughter will be sharing a room with several other BDCD participants.*
- 5. FOOD:** *I authorize BDCD to provide my daughter with food over the course of the weekend. I certify that I have provided all allergy and medical details on the original contract submitted during the 2014 season registration.*
- 6. SWIMMING AND TOURING:** *I authorize BDCD to allow my daughter to go swimming in the Jockey Club community pool. I also authorize BDCD to take my daughter on touring field trips along the strip of las vegas and within various casino's within age appropriate area.*
